### Course description

The SUSTAINS LC staff strives to provide co-curricular programming based on the areas of community development, sustainability education, social equity, and service, as we feel that such programming is an essential part of your experience learning about sustainability as it relates to society. This course is structured to provide students with academic credit for their participation in meaningful programs and events throughout the semester.

### Learning outcomes

By the end of this course, students should successfully be able to:

- Have a greater connection to the SUSTAINS Learning Community and the academic units involved in sustainability initiatives

- Be able to craft a thorough, working definition of sustainability
- Acquire an understanding about the relationship between sustainability, leadership, and citizenship
- Gain a greater appreciation for social justice, social change, ethics, and values in the public sector
- Become more comfortable having in-depth discussions about relevant sustainability topics
- Be confident in their abilities to develop a sustainability-focused project

## HOW THIS COURSE WORKS

**Mode of delivery:** This course will be delivered in-person, with assignments facilitated through Carmen.

**Credit hours and work expectations:** This is a **1-credit-hour course**. According to Ohio State policy ([go.osu.edu/credithours](https://go.osu.edu/credithours)), students should expect around 1 hour per week of time spent on direct instruction (instructor content and Carmen activities, for example) in addition to 2 hours of homework (reading and assignment preparation, for example) to receive a passing grade.

**Attendance and participation requirements:** Students are expected to attend all in-person meetings and complete all in-person and virtual activities. The following is a summary of students' expected participation:

- **Class Participation:**

In order to earn the points for Class Participation, you must complete all activities and requirements for that week. If class is meeting in-person, you will be expected to attend class on-time and actively participate during class.

- **Participating in activities and events for attendance:**

You will receive points for your participation in various Learning Community events and activities throughout the semester. Each event and activity is unique and will be worth a different number of points depending on time, level of involvement, and other requirements.

- **Office hours: OPTIONAL**

Office hours are never required and you will not gain participation points for attending them. During office hours, I will be happy to assist you with class assignments and answer any questions you have about the class or other LC activities.

- **Group work and presentations:**

A major component of the class will be your group project. You are expected to meet at least weekly with your group once groups are assigned. Groups are free to meet virtually or in person, depending on the preferences of the group members. Your final presentations will be delivered at the end of the semester during class-time to Gina Jaquet and others.

## Carmen access

## Descriptions of major course assignments

### Class Participation

**Description:** You are expected to attend all classes and participate in all required activities before their specified due date. If you are unable to attend a class or complete an assignment by its due date, you must contact Gina, preferably before the due date. Only a valid excuse will be accepted for not completing an assignment on time. Valid excuses include: extended illness, family or personal emergency, extended loss of access to technology, unforeseen change in circumstances, etc.

### Event and Activity Attendance

**Description:** You will receive points for your participation in various Learning Community events and activities throughout the semester. Each event and activity is unique and will be worth a different number of points depending on time, level of involvement, and other requirements. To earn points, you must stay for the duration of each event. NOTE: Students can count a maximum of 15 points from LC events that are strictly social in nature toward their total.

Events must be university approved, and be related to sustainability education, service, or dialogue. Examples of acceptable events include a campus lecture by a faculty member related to sustainability or a service project with a student organization. Purely social events or regular student organization meetings will not be acceptable. All outside events must be approved by Gina, and students must provide proof of their attendance.

### Final Project

**Description:** Your assignment is to make a single recommendation for improving sustainability efforts on Ohio State's campus. You may choose to develop a new plan or program designed to improve our campus sustainability efforts; or you may choose to discuss how to improve existing efforts. Students will work in project groups and will give a presentation to Gina and others by November 29th. A PowerPoint document of the presentation must be submitted to Carmen by November 1st at 11:59pm in order to receive project feedback.

In your presentation, you should discuss the following topics:

- What is your plan?
- Why is it needed?
- What is the timeline from the inception of the project through project completion? Can you implement this during spring semester?
- How does your plan directly connect to the OSU student community and relate to increased knowledge or engagement around sustainability topics?

- What are the perceived strengths of your plan?
- What opposition to this project might exist?
- Without getting too specific, what are the costs of implementing your plan?
- Have other OSU campus groups tried something similar? If so, what did they find? If not, why do you think your plan is the right approach to the issue?

### **Requirements:**

- Each group will be required to interview two current members of the campus or University district community. These people may be faculty or staff of the university or Columbus community. The purpose of these interviews is to get some feedback from people who have been around Ohio State for some time on the need for your proposed program or project and to gain some feedback from them about how to change or improve your program.
- Each group must submit a proposed list of people they intend to contact before interviewing, along with a one paragraph summary of the direction of your project. This will be due in Carmen by October 4th 11:59pm. Your interview list must be approved by Gina prior to contacting the individuals on your list.

**Presentation:** Each group will be required to make a group presentation to Gina Jaquet and others on November 21<sup>st</sup> or 28<sup>th</sup>. The presentation should:

- Be 8-10 minutes in length.
- All group members must have a speaking role.
- Include audio/visual aids.
- Discuss the feedback you received from the members of the campus/University community.
- We will discuss the programs as a class, with the goal of determining if the LC can be a part of the implementation of some of these new initiatives.

### **There is No Final Exam**

**Academic integrity and collaboration:** This course includes group projects, which can be stressful for students when it comes to dividing work, taking credit, and receiving grades and feedback. I have attempted to make the guidelines for group work as clear as possible for each activity and assignment, but please let me know if you have any questions.

## Late assignments

Late submissions will not be accepted unless you contact Gina before the due date with an accepted excuse. Please refer to Carmen for due dates. If an emergency arises, please communicate with Gina and accommodations will be made on a case-by-case basis.

## Instructor feedback and response time

I am providing the following list to give you an idea of my intended availability throughout the course. (Remember that you can call **614-688-4357(HELP)** at any time if you have a technical problem.)

- **Grading and feedback:** For large assignments, you can generally expect feedback within **7 days**.
- **Email:** I will reply to emails within **24 hours on days when class is in session at the university**.

### Discussion and communication guidelines

The following are my expectations for how we should communicate as a class. Above all, please remember to be respectful and thoughtful.

- **Writing style:** While there is no need to participate in class discussions as if you were writing a research paper, you should remember to write using good grammar, spelling, and punctuation. A more conversational tone is fine for non-academic topics.
- **Tone and civility:** Let's maintain a supportive learning community where everyone feels safe and where people can disagree amicably. Remember that sarcasm doesn't always come across online.
- **Citing your sources:** When we have academic discussions, please cite your sources to back up what you say. For readings, list at least the title and page numbers. For online sources, include a link.
- **Backing up your work:** Consider composing your academic posts in a word processor, where you can save your work, and then copying into the Carmen discussion.
