**DESCRIPTION OF COURSE:** Nature and need for business records, analysis, and interpretation of essential records from manager/owner viewpoint and their use in small business practices. **REQUIRED TEXTBOOK:** There is an e-textbook and My Accounting Lab (MAL) subscription as part of Carmenbooks and is included with the course fees. **COURSE OBJECTIVES:** AEDE 2105 is an intermediate-level course designed to introduce students to managerial tools needed to operate a small business. A sustainable business requires effective planning, accurate record keeping, and financial management. Course materials and assignments will focus on becoming proficient with the accounting cycle using both manual and computerized accounting systems; analyze financial reports for accuracy; and analyze financial results for performance by identifying strengths and weaknesses of the business.

This course stresses the impact of record keeping on the ability of a small business to achieve its strategic goals. After establishing a foundation in accounting principles, a problem-based and problem-solving learning approach will be taken allowing students to gain a working knowledge of analyzing financial results. Through laboratory exercises and assignments, students will learn to perform the various accounting functions using a manual-based accounting approach and using accounting software and analyzing financial results.

**SUCCESS IN THIS COURSE:** AEDE 2105 is an 100% live in person course. Accounting can be a challenging discipline for majors and non-majors. There are three keys to being successful in this course: 1) **master the content of Chapters 1, 2, 3, and 4**. These are the foundational chapters for the entire course; 2) engage daily with the course materials – you learn accounting by securing principles and then by DOING it – practice often!; 3) immediately reach out to your instructor should you need assistance or clarification about a concept or topic – **do not wait to seek help.** 

#### STUDENT RESPONSIBILITIES

As a student in this course, it is your responsibility to:

- Read and use all of the course content provided in Carmen.
- Check your e-mail account daily.
- Complete and submit assignments on a timely basis using Carmen. **No** assignment will be accepted for credit if it is submitted past the due date or if the assignment is not submitted through Carmen.
- Print preview all of your assignments before submitting them for grading to ensure that they are print ready and in good form.
- All assessments (unit assignments, course project, quizzes and exams) are to be your own individual work. There is no group work in this class. Any and all instances of possible academic misconduct where students collaborate on assessments will be given a score of zero and reported to the Office of Academic Misconduct.
- Complete all exams according to the course schedule. There are no exam makeups in this course. All exams will be available through Carmen and proctored live during class. View the exam dates in the 'Assignments' tab in Carmen so that you do not miss anything.
- Obtain or have access to the required hardware and software for this course.

#### STANDARDS AND METHODS FOR EVALUATION:

Tests, quizzes, assignments and course projects have the following weights and your course grade will be determined based on the following scale:

- 1) My Accounting Lab Pre-Homework (13 chapters @ 10 points each) 130 points
- 2) My Accounting Lab Post Homework (13 chapters @ 20 points each) 260 points
- 3) Exams (4 @ 100 points each) 400 points
- 5) Participation and Professionalism 90 points
- 6) Discussion Posts (4 @ 30 points each) 120 points

Total possible points for course: 1,000 points

1) My Accounting Lab (MAL) Pre-Homework: For each chapter there is pre-homework to complete prior to listening to the lecture. All the homework is to be completed by the assigned due dates. Each pre-homework assignment is 10 points and can be

- attempted multiple times. Grades will automatically be posted into Carmen once the due date has been passed.
- 2) My Accounting Lab (MAL) Post Homework: For each chapter there is post homework due that is 20 points each. On post homework you only have one attempt to complete the assignment. It is recommended to listen to the voice over Power Point files prior to completing the post homework. Grades will automatically be posted into Carmen once the due date has passed.
- 3) **Exams:** There are four exams during the course and will be conducted online. Each exam is for 100 points. The exams will be made up of a combination of multiple choice and written response. Ensure to bring a basic function calculator. **Tentative dates** for the exams are:
  - a. Exam #1 Chapters 1 3: Wednesday, 01/31/2024
  - b. Exam #2 Chapters 4 6: Monday, 02/26/2024
  - c. Exam #3 Chapters 7 9: Wednesday, 03/27/2027
  - d. Exam #4 Chapters 10 13: Monday, 04/30/2024 (do not schedule flights to return home or other travel plans prior to the final exam date). Graduating seniors will have to take exam #4 prior to 04/30/2024.
- 4.) **Discussion Posts**: During the course there will be four discussion posts. Each post is for **30 points each**. Students are **REQUIRED** to participate constructively in class discussions.
  - Original posts (20 points) Discussion boards are open for 7 days. At the beginning of discussion board students need to post a short (3 to 4 sentences) post with discussion points to Carmen discussion board for the respective period.
  - Responses (10 points/5 points each response) Students need to respond to with two different discussion posts by other students and provide valuable feedback prior to the due date.
  - Both original posts and Responses must be completed for eligible points
  - Generic posts (e.g. I like this idea; Good job; I completely agree/disagree with this) do not count as a posting. You need to provide meaningful feedback and add value to the discussion.

**Extra Credit Statement:** As a general rule, there is **NO** planned extra credit assignments for this course. Any extra credit is at the discretion of the professor and would be announced to the complete class. There will be no extra credit given to any individual student or groups of students.

#### **GRADING SCALE AND POINT DISTRIBUTION**

Course grading is based on the total points earned of the total points possible (total points earned divided by total points possible equals percentage earned). **Rounding Note:** There is **NO** rounding given to the final grade. Each letter grade has a minimum score to attain it. As an example, if your final score was 92.7% is would be a letter grade of A-. It would **NOT** be rounded up to 93.0% which is the minimum score needed for a letter grade of an A.
