## **Course Prerequisites**

AEDECON 4001 (500) or Econ 4001 (501). Students should review the material in appendices A through D of the Greene textbook (matrix algebra, probability and distribution theory, estimation and inference, large sample distribution theory) throughout the term. Students should acquaint yourself with at least one statistical software package (see options above); all assignments will involve computer applications. Students are free to use the software of their choice to complete assignments.

## **Course Description**

This is the first in a two-course sequence in applied econometrics for first-year doctoral students in AED Economics. The purpose of the course is to provide a rigorous graduate-level introduction to techniques and applications of econometric analysis that are necessary to conduct sound empirical research. Lectures and labs will feature discussion of technical concepts and computer applications using real and simulated datasets.

## **Course Learning Goals and Outcomes**

1. Advanced mastery of econometric estimation techniques:



- Students will demonstrate proficiency in the theory and application of a range of econometric methods at the doctoral level, including OLS, IV, MLE, Limited Dependent Variable Models, Panel Data and Sample Selection methods and understand their strengths and limitations.
2. Effective model specification and diagnostics:
- Students will exhibit the ability to meticulously specify econometric models, assess underlying assumptions, and conduct rigorous diagnostic tests, ensuring the robustness and reliability of the analysis.
3. Econometric application to complex real-world problems:
- Apply econometric tools to address real-world economic issues, demonstrating the capability to interpret and communicate nuanced empirical results to both technical and non-technical audiences, as expected at the doctoral level.

### How This Course Works

Mode of delivery: This course is taught in person. Students are expected to attend class each week during the scheduled meeting sessions.

Credit hours and work expectations: This is a 3 credit-hour course. According to Ohio State bylaws on instruction ([go.osu.edu/credithours](http://go.osu.edu/credithours)), students should expect around 3 hours per week of time spent on direct instruction (instructor content and Carmen activities, for example) in addition to 6 hours of homework (reading and assignment preparation, for example) to receive a grade of B average.

Attendance and participation requirements: Research shows regular participation is one of the highest predictors of success. Attendance is a critical part of your success in this course hence it is mandatory, except in cases of documented emergency or excused absence. Each unexcused absence will result in a penalty of 3 percentage points of your grade for the semester unless your absence is due to a documented emergency.
